

ABOUT THE AUTHOR

Carol Costa was born and raised in Chicago, where she bugan to write at an early age. Her first published work was a high school essay telling of her love for books.

Carol has been married to Frank Costa since 1965, and they have four children, Christopher, 20, Lisa Marie, 18, Joseph, 15, and Maria Lynn, 8.

The Costa family moved to Tucson in 1973 and Carol resumed a career in public accounting. It was here that she met a director from the community theater who coaxed her into writting her first stage piece, a ten minute comedy skit about vampires. The skit was produced as part of a variety show. The audience laughed in all the right places and Carol has been hooked on live theater ever since.

After a few years of writing skits, acting and directing with local groups, Carol enrolled in a creative writing class at the University of Arizona. It was 1979, time to take her writing more seriously, so she learned how to market her work and began to send it out.

The sale of a short story in April, 1980, led to other short fiction sales and numerous non-fiction assignments. Within the year, she completed her first full length play, "Death Insurance", a murder mystery laced with humor.

Four years passed and six more plays were completed. Some received local productions and one of them, a children's Christmas play was published in 1982. However, the opportunities and financial rewards for playwrights seemed to be few and far between, so Carol turned her efforts to novels, radio scripts, and screenplays, and succeeded in having one of the radio scripts produced by a Los Angeles radio station.

Then in 1986, the impossible happened. Carol submitted "Death Insurance" to a New York theater that specialized in murder mysteries and it was accepted.

An exciting trip to New York and a lot of local publicity prompted Carol to write a new play. The original concept was a murder/mystery set in the roaring twenties, but he zany characters that began to parade across the pages of the script refused to take the plot seriously, so Carol let them have their way and the new play, "Big Al Goes Straight", became more comedy than mystery.

Six months after it rolled out of her typewriter, Carol was overloyed to learn that "Big Al" was to receive the Robert J. Pickering Award for Playwriting Excellence.

Like any writer, Carol faces rejection on a daily basis, but in the last six months, the yea's have begun to overshadow the no's, and several exciting projects are in the works.

In addition to her job as the Club Accountant of Elks Lodge #385, Carol works with a local theater group, conducts a comedy writing workshop and a playwriting class at Tucson's Author's Resource Center, and is treasurer of the local chapter of the Romance Writers of America.

Carol is also a member of the Dramatists Guild which she feels is a "must" for any playwright.

Carol is looking forward to seeing "Big Al" produced in Coldwater, and is currently looking for some nice warm clothes to take on her trip.

KEN WOLFE

Ken Wolfe has been a resident of Branch County for 35 years. This is his first appearance on stage since he graduated from Bronson High School in 1970. He has been employed as a tool & die maker at Douglas Components Corp. in Bronson for the last 14 years. He enjoys singing and holds a degree in computer programming.

BILL SHOOP

Bill Shoop is a long time member of C.C.T. Recent credits include direction and settings for the fall production of "Harvey" and the role of Pericles in the original play "Cooperative Living" two seasons ago. Bill is a self employed woodworker. Other interests include tennis, antique cars, and travel.

TOM HARMON

Tom Harmon is making his fifth C.C.T. appearance. He previously appeared in "California Suite", "The Good Doctor", "Little Mary Sunshine" and "Come Blow Your Horn". His first appearances were in high school with "She Stoops to Conquer", "A Christmas Carol", and a comedy which shall go unnamed. Tom and his children Andi and Jon live in Coldwater.
