

About the Robert J. Pickering Award for Playwrighting Excellence

The presentation of AUTHORS ANONYMOUS, by Carl L. Williams, marks the 25th production to win this prestigious award.

When the award was initiated in 1984, the three Pickering shows produced in 1979, 1981 and 1984 were the first recipients. Beginning in 1985, the actual award was presentation of the manuscript. To most new authors this is better than money! In 1987 monetary awards for 1st, 2nd and 3rd place were added.

The award is now international and enjoys an outstanding reputation. Several winning scripts have been published. CCT is proud to be the only amateur theatre group in Michigan to offer this program.

A note about this year's winning author:

Carl L. Williams of Houston, Texas, is the winner of the prestigious Robert J. Pickering Award for Playwrighting Excellence. His play was selected from over one hundred scripts submitted by authors from all over the world.

Mr. Williams, whose real-life occupation is as a social worker, has been writing plays for about twelve years during which five of his full-length plays and three one-act melodramas have been published. He is a member of Theatre Southwest, Dramatists Guild of America and Texas Nonprofit Theatres. Upon hearing that he had won the only award given by a local theatre group, Carl stated, "I was thrilled and delighted. We writers labor over our works and then send them out, not knowing what may become of them. To learn that someone enjoyed the play enough to award it the top prize is the ultimate in validation."
